SPECIAL NOTICE RELATED TO THE COVID-19 VIRUS

1. Please **DO NOT COME** to our trial if you feel sick, or if you have tested positive or if you have been exposed to COVID-19 in the last 14 days before the trial. **DO NOT COME** if you are concerned about being exposed to COVID-19. Please do not enter this event if you are not willing to follow these rules.
2. Please bring a face mask to the trial. You will be required to wear a mask when inside the building and while showing in the ring and everywhere on the club grounds. You will not be able to enter the building without wearing a mask. You will not be able to enter the building until it is time for your class to show in the ring.
3. Please maintain 6 foot social distancing while interacting with anyone in the show.
