2. Masks will be required for everyone regardless of vaccination status. You will be required to wear a mask when inside the building. The Judge will be wearing a mask in the ring. The Judge is okay with participants removing their mask while showing their dog in the ring.
3. Please maintain 6 foot social distancing while interacting with anyone in the show.
4. Disinfecting spray will be available in the restrooms. Please spray down anything you touch after using the restroom.
5. Hand sanitizer will be available in areas through the club for use. Please wash your hands using soap and water as frequently as possible.
6. There will be room for crating in the building for dogs. You may also crate your dogs in your car and/also remain in your car until your class is ready to show.
7. There will be no food or beverages provided. Please bring your own food and beverage if desired.
